Opens September and closes in November the year before.



# MERIT AND EQUITY.

You can apply for a scholarship under either merit and/or equity.



### **MERIT**

Scholarships awarded on the basis of merit seek to reward applicants' academic achievements and leadership within the Institute and across the community.

If you're interested in applying for a scholarship awarded through merit, keep an eye out for the yellow!



## **EQUITY**

Scholarships awarded on the basis of equity aim to provide financial support to students that have experienced, or are experiencing, financial and/or educational disadvantage.

If you're interested in applying for a scholarship awarded through equity, keep an eye out for the green!

# APPLYING THROUGH MERIT.

At the William Angliss Institute, we define merit as:

Demonstrate academic excellence via results achieved during previous and current studies.

#### MERIT APPLICATION REQUIREMENTS

To apply for merit, you require the following documents:

- An updated resume (see pp. 13-15)
- · Two letters of support:
  - One letter from an academic contact (see pp. 16-18)
  - One letter from an external source (see pp. 16-18)
- Academic Transcript (see p. 26)

# MERIT APPLICANT STATEMENTS.

To apply for merit, you are required to write four statements, no more than 200 words each. You'll be asked to answer the following:

- Why have you chosen to undertake your course of study, and what are your long-term career goals?
- · Discuss your academic performance and achievements in your studies.
- Provide an example of when you have demonstrated leadership skills in your studies and professional life.
- · How do you intend to use the scholarship funds?



You should use your statements to set yourself apart from the other applicants. See p. 27 for more tips on writing your applicant statements!



Your resumé can make or break your scholarship application! Ensure that you can provide an up-to-date and professional-looking resume with your application that can effectively demonstrate your work experience to date.

A professional-looking resumé is a marketing tool that job seekers use to communicate their value to employers. It should clearly outline your experience, qualifications and achievements.

A resume is effective if the recruiter/employer chooses you over the other candidates (at least for an interview).

# YOUR LETTERS OF SUPPORT.

You require two supporting letters for your scholarship application. These letters must be current and official:

- · Include letterhead where possible
- · Contact details of your referee (name, signature, contact number and/or email)

#### ACADEMIC LETTER OF SUPPORT

This support letter should come from a contact within an educational setting. Most applicants ask a staff member at the Institute.

This letter should demonstrate your willingness to learn and engagement within the classroom.

#### EXTERNAL LETTER OF SUPPORT

This letter should come from a contact that can demonstrate your community involvement and/or leadership achievements.

Most applicants choose to ask their employer, but you can also attain a letter from a community worker, counselor, church leader, doctor, etc.

Include letterhead (if possible), email and/or phone number.

Dear Scholarship Committee,

I am delighted to recommend John Saunders for the merit scholarship. # APPLYING THROUGH EQUITY.

At the William Angliss Institute, we define equity as:

Demonstrate financial and/or education disadvantage.

#### **EQUITY APPLICATION CRITERIA**

To apply for equity, you must fit under one, or more, of the following categories:

- Have a disadvantaged financial background (see pp. 21-22)
- Are from, or are intending to move from, a rural or regional area (see p. 23)
- Are an Aboriginal and/or Torres Strait Islander (see p. 24)
- Have disability, long-term medical illness or mental health condition (see p. 24)
- · Experience difficult circumstances (see p. 25)

#### **EQUITY APPLICATION REQUIREMENTS**

Your application requirements are dependent on the equity criteria that you are applying through.

Regardless of the criteria that you're applying through, you still require an Academic Transcript (see p. 26)

# EQUITY APPLICANT STATEMENTS.

To apply for equity, you are required to complete three statements. These statements shouldn't exceed 200 words each. You'll be asked to answer the following:

- Why have you chosen to undertake your course of study, and what are your long-term career goals?
- · Discuss your academic performance and achievements in your studies.
- · How do you intend to use the scholarship funds?



You should use your statements to set yourself apart from the other applicants. See p. 24 for more tips on writing your applicant statements!

# FINANCIAL HARDSHIP.

If you are experiencing financial hardship then you can apply for equity through this category.

We understand that financial hardship can impact international and domestic students differently, so there are different application requirements for both international and domestic students.

#### DOMESTIC STUDENTS

#### General Financial Hardship:

If you are a domestic student and you are experiencing financial hardship, then you can apply through 'General Financial Hardship'. To apply for this, you must:

- Select your current living situation (living independently; supported by parents/spouse; other)
- Provide a copy of your ATO income statement for the most recent financial year
- Write a statement that details your current financial and living circumstances including how they are affecting your study

#### Centrelink Benefits:

If you are also receiving Centrelink benefits, then you can include this in your application. To include this, you must:

- · Outline which benefit you are currently receiving
- Provide supporting documentation to prove that you are receiving this benefit

#### INTERNATIONAL STUDENTS

If you are an international student and experiencing financial hardship, then you must provide the following:

- · One to three of your most recent payslips
- · A copy of your bank statement
- · Any additional supporting documentation
- Write a statement that details your current financial and living circumstances including how they are affecting your study

# FROM A RURAL OR REGIONAL OR INTERSTATE AREA.

If you are from, or intending to move from, a rural, regional or interstate address, then you can apply for equity through this category. Although there is no remoteness requirement, the Committee will consider the 2016 ASGC remoteness of your address.

#### If you have moved within the last two years

To apply for this, you must:

- · Provide evidence of your current address
- · Provide evidence your previous address
- · Outline when you moved

#### If you are planning to move

To apply for this, you must:

 Provide evidence of your current address that demonstrates that you are from a rural, regional, or interstate area

# ABORIGINAL OR TORRES STRAIT ISLANDER.

If you identify as an Aboriginal and/or Torres Strait Islander, you can apply for a scholarship through equity.

# DISABILITY, LONG-TERM MEDICAL OR MENTAL HEALTH CONDITION.

If you have a disability, long-term medical or mental health condition that impacts your ability to study, then you can apply through this category.

To apply for this, you must:

- Outline which disability, medical illness or mental health condition(s) you are living with
- Detail how your condition affect your ability to participate in your course
- Provide a current detailed letter from a local medical health provider, or evidence disability payments

# EXPERIENCE DIFFICULT CIRCUMSTANCES.

Sometimes, difficult circumstances don't fit into neat categories. If something you are facing is having a negative impact on your education and you wish for it to be considered as part of your scholarship application, you can provide a document as evidence.

To apply for this category, you must:

- · Write a statement that describes your circumstances
- · Provide one to two supporting documents

# YOUR ACADEMIC TRANSCRIPT.

Your academic transcript is your official record of study at the William Angliss Institute (WAI). You are required to provide your academic transcript for both merit and equity applications.

You can attain your unofficial transcript from WAI Information Centre.

If you have recently started studying at WAI, and your final results are yet to be released, then you can collate evidence of your current results.

Academic transcripts from the Institute are preferred if they're available; however, if you are yet to start your studies at WAI, then you can provide your academic results from another educational setting instead (e.g. school report, previous academic transcript etc.).

# WRITING YOUR STATEMENTS.

Your applicant statements are your opportunity to explain your situation to the committee assessing your application. The panel assessing your application wants to get to know you and get an idea of who you are.

You should consider the following when writing your statements:

- · What sets you apart from your peers?
- · What are your goals? What path are your studies taking you on?
- · Why do you need or deserve the scholarship?
- · Why you?

While your statements should indicate that you have invested time and effort into your application, each statement should not exceed 200 words.



Your written statements are your only opportunity to 'speak' to the Scholarship Selection Committee. Make sure that you are reflecting yourself the best you can!

# STANDARD OF EVIDENCE.

Your documentation provided should reasonably 'prove' your situation.

Any document you provide should be current. This means that it should be dated within the last three months. The only exception to this is rural/regional documentation, which can be dated within the last two years (see p.23).

Here are some general rules to ensure that your documentation is reliable and verifiable:

- It should be written by someone in a position of authority (not yourself or a family member/friend) who is qualified to comment on your circumstances, i.e. teacher, lawyer/accountant/health care provider
- · Preferably as specific as possible
- · Dated
- · Either on official letterhead or containing an original signature

· All documentation must be written in English

# SOME SPECIFICS...

#### **Centrelink Documents**

Centrelink documents must include:

- · Your name
- · Date
- · Address
- · Date of birth

You can include a Centrelink income statement or card. Which documentation you use is whichever you believe will best reflect your circumstances.

#### **Rural or Regional Living**

If you've already moved within the last two years, you must provide proof of previous address (e.g. a copy of a utility bill, or a rental agreement demonstrating when you moved in).

If you're planning to move, you must provide evidence of current address (e.g. a copy of a recent utility bill, or a rental agreement).

#### **Bank Statements**

If you are an international student applying through financial hardship, then you must provide a bank statement. Screenshots are not accepted.
